- 1) **Heather Cox Richardson** is an American historian, author, and educator. She is a professor of history at Boston College, where she teaches courses on the American Civil War, the Reconstruction Era, the American West, and the Plains Indians. She publishes a daily newsletter that is free of charge. To subscribe go here (Substack Letters from an American). Rather than proselytizing, she expounds on the historical background of current events, giving historical perspective that illuminates how we got here and where it could lead us. - 2) Joyce Vance is an American lawyer who served as US attorney for the Northern District of Alabama from 2009 to 2017. She was one of the first five U.S. attorneys, and the first female U.S. attorney, nominated by President Barack Obama. She also writes a daily Newsletter entitled Civil Discourse. Her particular expertise is the judicial system and political events pertaining to it. - 3) Robert Reich (1946) is a prominent American professor, author, lawyer, and political commentator. He worked in the administrations of presidents Gerald Ford and Jimmy Carter, and served as Secretary of Labor from 1993 to 1997 in the cabinet of President Bill Clinton. His daily Substack addresses, among other things, the economic side of current events. - 4) **Rick Wilson** is an American political strategist, satirist, media consultant, and author based in Florida.
